LAHOA Report

Treasurer Report

Helen Alex shared the P & L Financial Statements for the period ending July 31, 2023 with the presidents. The Budget for the 2023-2024 playing season will be presented at the next board meeting. Dave Bigelow informed the presidents that we are still paying for storage costs at a facility that was originally contracted by Sandy Blumberg. Dave stated that we should look into getting rid of the storage since there really isn't much of anything stored there except for boxes of old documents. The storage unit is in Anaheim.

Commissioner's / Ice Convener Report

Dave Bigelow thanked the presidents for submitting their ice slots as well as completing all of their AA LOI's in a timely manner. In addition, all of the bye requests for the AA teams were also submitted. Any bye requests that were mistakenly left out, presidents will have until tomorrow morning August 17, 2023 to get them into the google form.

Dave Bigelow shared his working AA draft document with the presidents. In the 16UAA division there are 15-Teams. The teams are split into two brackets; east and west. The top five-(5) Teams from each bracket will advance to the CAHA Cross-over weekends with the Northern teams. The remaining 16UAA teams will continue with the SCAHA season schedule. For the first Cross-over weekend, November 17-19, 2023 the following four teams have been identified to participate in. They are the following: Empire HC, Jr. Ducks(1), Wave(1) and OC Hockey(2).

In the 14UAA division there are 18-Teams. The teams are split into two brackets; east and west. The top six-(6) Teams from each bracket will advance to the CAHA Cross-over weekends with the Northern teams. The remaining 14UAA teams will continue with the SCAHA season schedule. For the first Cross-over weekend, November 10-12, 2023 the following four teams have been identified to participate in. They are the following: Empire HC, Jr. Ducks(2), SDIA and Jr. Kings(1).

In the 12UAA division there are 13-Teams. The teams are split into two brackets; east and west. The top four-(4) Teams from each bracket will advance to the CAHA Cross-over weekends with the Northern teams. The remaining 12UAA teams will continue with the SCAHA season schedule. For the first Cross-over weekend, November 10-12, 2023 the following four teams have been identified to participate in. They are the following: Goldrush, Bears(1), Bears(2) and Jr. Ducks(1).

In the 18UAA division there will be no pool play. The teams will play each other once and all will advance to the Cross-over weekends.

Deputy Commissioner Report

Rosemary Voulelikas reminded all that the SCAHA Financial Assistance Application form is posted on the SCAHA website. The deadline to submit applications is by 5 pm October 15, 2023. Rosemary informed the presidents that she will be reaching out to them to serve on the SCAHA Disciplinary Committee.

Ice Convener Report

Dave Bigelow re-iterated to the presidents to complete their A/BB/B LOI's. Let Dave know if your team will be moving a level as soon as possible. Dave reminded the presidents that the A/BB/B teams have one bye weekend. Please make sure the information is submitted on the google form. Exhibition teams do not have a bye request. Exhibition teams can expect 8 to 10 games scheduled in the SCAHA Regular season schedule.

Statistician Report

Rob Foster informed the board that the patches (Shut-out, Playmaker and Playoff) have been all sent out about two weeks ago. He stated that he received positive feedback from the families. Reminders, if teams are attending tournaments they need to submit their request to Rob Foster and then once the games are completed, the team managers will need to upload their tournament scoresheets. And finally, the AA Team managers will need to upload their games both on the SCAHA and CAHA web sites.
