Minutes

Joel Henderson motioned to approve September 10, 2025, minutes as presented. Chris Holloway seconds. (motion **PASSED**)

LAHOA Report

Louis Magnifico informed the board that they have completed 14 Officiating seminars and that they have six left to complete. There are about eighty officials 18U that have registered and most of them are from Irvine. Dan Ellison reported that a Learn to Coach/Officiate was held with fifty female officials and all went well. And finally, they held a clinic in Mammoth last weekend and that went well as well. Reno officials are interested in helping in Mammoth.

Treasurer's Report

Helen Alex is absent. Dave Bigelow shared the P & L financial documents with the presidents for the period ending September 30, 2025.

Commissioner's & Ice Convenor Report

Dave Bigelow informed the presidents to send to Dave and Nick Silver the 8U team movement across all divisions asap so that the second phase of the 8U scheduling can be finalized this weekend.

Dave Bigelow shared the spreadsheet showing the 14UAA, 16UAA and 18UAA teams attending the first CAHA cross-over weekend, November 14-16, 2025. Originally, the Ice Dogs 14UAA were supposed to go that first weekend, however, they are on the bubble and Dave suggested the Jr. Condors go instead. This will affect the Nov. 23rd game 14UAA Jr. Condors vs Flyers. Dave will send an email with the schedule change for Nov. 23, 2025. In the 18UAA division, all teams go to cross-over weekends. Dave Bigelow stated that he will send the list of the 14UAA, 16UAA and 18UAA teams that will be attending the first CAHA cross-over weekend to Rob Foster to post on the SCAHA website.

Deputy Commissioner's Report

Rosemary Voulelikas advised the presidents that the SCAHA Guidebook will be posted soon. Section 18 Tryouts will revert to the previous rule language mimicking CAHA's 6.19 Tryout rule. During the September 27, 2025 CAHA meeting, the dates for tryouts were reviewed, changed, and voted under The CAHA Calendar discussion section and not during the proposed rule change section. The actual rule change will require a vote during the next proposed rule changes. The CAHA Calendar as posted on the CAHA website shows the dates for the 2026-2027 tryouts.

The venues that successfully bid for the SCAHA Playoffs have been posted on the SCAHA website. The next step is to review the number of playoff berths per age division. This discussion will occur during the November-December meetings.

Rosemary Voulelikas stated that the SCAHA Financial Assistance applications are due today, October 15, 2025. So far, we have received about one hundred and thirty applications.

Reminder regarding Supplementary Discipline. Complaints for egregious acts committed by players and/or coaches not assessed during game play must be reviewed by the club presidents first and if the club presidents deem it "match" worthy, then same can be submitted by the club presidents **only** to the SCAHA Deputy Commissioner for A/BB/B levels and submitted to the CAHA 1st Vice President for Tier AA/AAA levels.

Statistician Report

Rob Foster reported that he is having to remind some of the 10U repeat offenders to upload their scoresheet and enter their stats. Reminder all 5-minute Majors carry a Game Misconduct regardless of whether the scorekeeper notated the GM or not.

Rob Foster gave an update on the 10U Half-Ice event hosted by SCAHA December 13-14, 2025, at Great Park. The 10UBB division filled up within 20 minutes. Rob stated that he is having difficulty getting interest in the 10UA division. Ideally, SCAHA would prefer 10UA teams. Some discussion followed regarding coordination, including how suspensions would be managed. Rob Foster encouraged presidents to attend and to please let him know if you will be attending.

Nick Silver reminded the presidents to please collaborate with your coaches to determine if teams are at the right levels. If not, please communicate the changes to Dave Bigelow and Nick Silver as soon as possible. The second phase of the schedule is expected to be released in the next few days.
